### DISCUSSIONS REGARDING THE TREASURER AND SECRETARY POSITIONS

In late April 2024, The Fire Island Pines Fire District was informed by our Auditors of a theft of \$21,866.18 from the Fire District bank accounts by its Secretary/Treasurer Patrick A. Forrett, when confronted on April 27, 2024, he resigned from the position and promised to repay all funds with interest in the next 1-2 weeks.

On May 15th, we were informed that all funds plus interest were repaid. About the same time, we received the physical evidence back from our Auditors. We immediately forwarded the information to our Attorney, William F. Glass for review and advice. We also asked that he follow through and report this to the Suffolk County District Attorney Office, and the resignation to the NYS Secretary of State.

On May 22nd, today, Attorney Glass informed us that he had all the original documentation in his possession. After his review he will forward the information to the DA's office in the coming week.

## MOTIONS: After brief discussions,

- 1. Comm. Coluccio moved to have Patrick Forrett removed as Administrator of our banking accounts at TD Bank, JPM Chase Bank and Bank of America. This action required Board resolutions to the banks. Comm. Cook seconded the motion; all were in favor, and the motion passed. Resolutions are attached for the file
- 2. Comm. Coluccio moved to have Commissioner Cook named as Account Administrator on all bank accounts at TD Bank, JPM Chase Bank and Bank of America. Comm. Rhodes-Teague seconded the motion; all were in favor, and the motion passed

- **3.** Comm. Geiman moved to renew our Certificate of Deposit at TD Bank for a 60 day term at the 5.09% rate quoted. Comm. Rhodes-Teague seconded the motion, all were in favor, the motion passed
- **4.** Comm. Rhodes-Teague made a motion to authorize purchase new AED pads for up to \$400.00. Comm. Coluccio seconded the motion; all were in favor, and the motion passed.
- 5. Comm. Rhodes-Teague made a motion to authorize purchase new insignia for Ex-Chief DeMeusy uniform per the Chief's request, up to \$500.00; Comm. Coluccio seconded the motion; all were in favor, and the motion passed.
- **6.** Comm. Coluccio moved to purchase a new mask for FF Rob Sperte, up to \$500.00 as requested in the Chief's request, above. Comm. Geiman seconded the motion; all were in favor, and the motion passed.
- **7.** Comm. Boss moved to appropriate up to \$700.00 for two additional special ferrys for transport to Yaphank SCFA training as requested in the Chief's request, above. Comm. Geiman seconded the motion; all were in favor, and the motion passed.
- **8.** Comm. Boss moved to appropriate up to \$1,400.00 to replace the washing machine in the Annex. After inspection last month, it was found to be not repairable. Comm. Coluccio seconded the motion; all were in favor, and the motion passed
- **9.** Comm. Rhodes-Teague made a motion to approve up to \$400.00 to move electrical outlets for chargers Comm. Boss seconded the motion; all were in favor, and the motion passed.
- 10. Comm Coluccio made a motion that the front door lock on the Fire House be replaced with a commercial grade lock up to \$800.00; Comm. Cook seconded the motion; it was approved by 4 members, Comm. Boss recused himself from the vote.

## **OLD BUSINESS:**

The Board continues to discuss the subject of the proposed OSHA changes to NSPA guidelines, which will bring enormous burdens to poorly funded and volunteer fire departments in twenty-eight OSHA states, of which New

York is one. For example, per the new guidelines, there is not a single firefighter in the Pines Department would qualify as chief, first assistant or second assistant. No decisions were made.

#### **NEW BUSINESS:**

The Board discussed the possible addition of Blue Point Beach to our Fire Protection District. It was decided that we will not do further research nor discuss again. Comm. Coluccio and Chief Merker spoke with Chief Merman of Brookhaven Fire Protection District; Chief Merker travelled down the beach to Blue Point Beach and reported that our vehicles could not get there and could not get over the dune and into the residential area. Logistically, we cannot do this. Comm. Geiman made a motion that we reject this concept; Comm. Rhodes-Teague seconded the motion; all were in favor, and the motion passed.
