SECRETARY REPORT -

Spoke of SAM renewal. We now have an additional feature to make an assignment for an administrator. After conversation it was determined that both the Treasurer and Secretary would now be listed in the bounce for <u>Commissioners@fipfd.org</u> account.

MOTION MADE to accept the minutes of the August 24, 2024 meeting with corrections by Commissioner Holly Rhodes-Teague, seconded by Commissioner Cook and all voted in favor.

TREASURER REPORT -

A lengthy discussion was had regarding the proposed 2025 budget for the District. Treasurer Mazella went through every line item in our budget.

MOTION MADE by Commissioner Cook, seconded by Commissioner Rhodes-Teague and voted in favor by all Commissioners, to accept the proposed 2025 District Budget. A notice of hearing will be posted on our website and sign board. Notice of Hearing will be sent to the Town Clerk. Hearing will be held on October 15th, 2024 at the firehouse.

Discussion was had regarding the Treasurer's Report, budget to actual, updated motion list, projected forecast for end of year expenditures, incremental payroll costs.

MOTION MADE by Chairman Boss for additional monies of \$1,156.00 needed for AC in Commissioner office. This was an emergency repair. Seconded by Commissioner Rhodes-Teague. Commissioners Geiman and Cook voted in favor, Commissioner Coluccio abstained.

MOTION MADE by Commissioner Coluccio and Seconded by Commissioner Cook for \$1,000.00 for four reciprocating saws and four Husky bags to be used for storage. All Commissioners voted in favor. NOTE: there was a prior motion for a larger amount that was not needed. This is the corrected dollar amount with additional storage bags.

MOTION MADE by Chairman Boss, Seconded by Commissioner Cook for an additional \$696.00 for Water Island hose testing. All Commissioners voted in favor. NOTE: Original motion was for \$4,176.00 (estimate from Waterways). Final bill was for \$4,872.

Discussion was had regarding the generator for firehouse and annex, a gas fired furnace for the annex. We need to try to obtain additional estimates. The District is having a hard time getting vendors to bid on work at the beach.

MOTION MADE by Commissioner Cook, Seconded by Commissioner Geiman for \$1,600 payable to Arthur Nelsen Electricians. Replace six new LED drop ceiling lights. All Commissioners voted in favor.

MOTION MADE by Commissioner Geiman, Seconded by Chairman Boss, in the amount of \$1,700.00 for TTP to work and repair outside cameras/security system. All Commissioners voted in favor.

Further discussed 2025 proposed budget, line by line.

Conversation was had regarding the Water Island contract. The estimate for the 2025 year of hose testing was \$5,124.00.

MOTION MADE by Commissioner Cook, Seconded by Chairman Boss in the amount of \$550.00 to purchase office supplies and a monitor for the commissioner's office. All Commissioners voted in favor.

MOTION MADE to approve the 2025 proposed budget, as long as we are within the 2% budget cap. Commissioner Cook made the motion, Seconded by Commissioner Rhodes-Teague. All commissioners voted in favor.

MOTION MADE to approve the Treasurer's Report by Commissioner Cook, Seconded by Commissioner Rhodes-Teague. All Commissioners voted in favor.

APPARATUS, EQUIPMENT, RADIOS - COMMISSIONER GEIMAN

Water Island hose testing completed. The vendor brought over 12 team members to do the hose testing. It went from 7:30 a.m. to 12:30 p.m.. We need to research how much hose is in Water Island. Commissioner Geiman thought that there was 7,000 feet. However the vendor claimed that there was 8,400 feet of hose. The did give us a 2025 estimate of \$5,124.00

Discussion on the new truck and a decision on the compartment needs to happen before the truck is shipped to Wisconsin. The current price for the truck is \$566,017.61. The new compartment that would be added would bring the pricing up to approximately \$573,000.00.

MOTION MADE by Commissioner Boss, Seconded by Commissioner Cook for \$7,500.00 for the design of the cab compartment for new truck. All Commissioners voted in favor.
