MOTION MADE by Commissioner Rhodes-Teague, seconded by Commissioner Boss to take \$7000.00 from Firehouse Repair budget and transfer to Equipment purchase budget. Commissioners Rhodes-Teague, Cook and Boss all voted in favor.

MOTION MADE by Commissioner Cook, seconded by Commissioner Boss in the amount of \$15,000.00 to purchase two complete sets of bunker gear. Commissioners Boss, Cook and Rhodes-Teague all voted in favor.

COMMITTEE REPORTS:

Apparatus, Equipment, Radios - Commissioner Geiman

Reminder to submit application at GOFEMA.GOV. There is a due date of 12/20 at 5 p.m.

UPDATE for the new 5-28-1. Truck was completed. Will be shipped to Wisconsin around January 15th, after rollup doors are completed. From there it will go to Custom Fire. They have a 3 month build time. Will go to Proliner in Medford also. Should be in the District in approximately June of 2025. At some point it will need to be inspected by members from the District in approximately April or May of 2025. Final inspection is not included in the pricing of the truck. That is a separate travel item bill.

5-28-1 had some damage. We were shown a picture. No way to fix the pipe in-house. It will have to go back to Firematic to be fixed. You cannot pump from the tank but you can pump off a hydrant. We do not know the costs until it is off the beach. Commissioner Boss inspected the damage in person. Suggested that we replace the elbow.

5-28-10 went out for repairs. They fixed the valves and the vehicle is ready to come back. A price was given to repair the roll bar, which is bent. The bill is \$1,200.00 + \$895.00 for a new light. It does not have to be repaired. There is a bill for \$582.00 to repair inlet and discharge.

5-28-5 & 5-28-9 have had recall work completed. Diagnostic test was done. We received a bill on the District credit card. Scrapes and scratches were discussed for both vehicles. We will get a price for body repair.

MOTION MADE for repair and shipping of 5-28-10 by Commissioner Boss in the amount of \$800.00, seconded by Commissioner Cook. Commissioners Boss, Cook & Rhodes-Teague all voted in favor.

INSURANCE, PUBLIC RELATIONS - COMMISSIONER COLUCCIO

Submitted the worker's compensation and disability applications. We should be getting quotes shortly. Bills will probably arrive in early January 2025.

Will need a final LOSAP report from the Department at the end of the calendar year.

On Thursday Suffolk County PD came to Commissioner Coluccio's office. Finalized subpoena and complaint for past Treasurer/Secretary. They are trying to figure out jurisdiction. Detective will forward the complaint that was signed. Det Ryan Wood from the Suffolk DA's office dealt with Commissioner Coluccio.

BUDGET, RECORDS - COMMISSIONER COOK

Wanted Board to be aware the tax revenues usually start to arrive in the District as of the first of the new year.

GROUNDS - COMMISSIONER BOSS

Still waiting for bills from Don Kollepah.

In reference to the generator, we will list a scope of work to try to attain bids for the generator project.

Was approached by FIPPOA regarding snow removal. We are trying to locate our signed agreement with the Town of Brookhaven. Want to know who is the assigned party at the beach who can request for snow removal during a storm. We need to determine a point person who the Town of Brookhaven deals with.
