Comm. Barry noted an e-mail from District attorney, Bill Glass, indicating that because of the Coronavirus pandemic, Gov. Cuomo has rescheduled all Fire District elections to September 15. Glass will provide an updated election timeline.

A conversation was held regarding meeting dates, now that election date must change. It was agreed that we will hold our July meeting on Saturday, July 11 at 10 AM. Forrett will post a notice in the Long Island Advance and on the District web site highlighting the change to the July meeting and noting the September 15 election date.

Comm. Barry informed the rest of the Board that, following last month's meeting, he and Comm. Coluccio spoke with Forrett regarding the District's credit card policy. In addition, the Board discussed the necessity of and options surrounding Covid antibody testing for the Department's first responders. Comm. Barry said he would discuss options with NDI and report to the Board.

Comm. Barry noted he dealt with Michael Greenburg's LOSAP paperwork and with an insurance adjuster for fire on Sunburst (Alarm 3740, noted above).

Comm. Corradino reminded the Board that, as it considers the on-going problems with the east- and west-end sirens, the siren pole at the Firehouse is rotting, and it also needs to be replaced.

The shed at the Annex is now completed; however, Comm. Corradino noted that the contractors used the wrong metal edging. Comm. Corradino has spoken with the contractors from Long Island Construction Plus, and the correct edging will be purchased and installed.

Comm. Corradino is waiting to hear about the disposition of the east side door of the Firehouse, the replacement of which was part of the November 2019 contract.

Comm. Corradino has spoken with the representative of the Pines Alcoholics Anonymous chapter, informing them that the Firehouse is shut until further notice and will not be available for AA meetings .

Comm.
